CCR – Article I: Definitions

– Add to definition of Lot and/or Lots, last sentence of paragraph:

Multiple lots re-platted by the Lot Owner through the City of Granbury Planning department are deemed to be one lot until such time as the lot is separated back to the original lots through the City of Granbury Planning department.



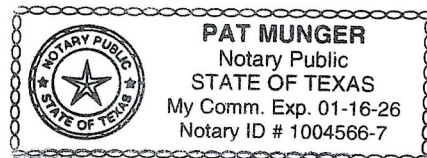
