There should be no discussion of fines during this initial conversation. Should the Owner require more than 30-days to remedy, the Owner shall submit a written request to the Board identifying a reasonable period of time for the violation to be corrected as long as the violation does not pose a threat to the Owner or other property, other property owners, or IS DETRIMENTAL TO the community at-large.
