CCRs: Article VII, Section 4(x) General Restrictions and Regulations (All Lots)

Remove Section 4 (x) (temporary moved to Section 3, qq, removed with 2025-2a)

There shall be only one all-purpose hauling trailer or 4-wheel, secondary utility or sport conveyance of any kind (boat, flatbed, golf, ATV, UTV, etc.) stored on a property for more than seven (7) days. Trailers must be parked in the lot driveway or under an RV cover. No trailer can be stored on grass or anywhere else on property.

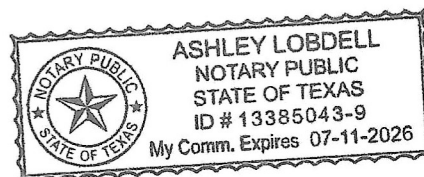
